

COMPASSIONATE GROUND APPOINTMENTS

Three separate waiting lists for appointment on compassionate grounds to the posts of Junior Assistant/Typist including Data Entry Operator, Office Assistant and Sweeper are being maintained. These waiting lists are not permanent ones. The seniority of the candidates in the waiting lists may change whenever new candidates are included in the waiting lists on the basis of their date of preferring the first application within three years from the date of death of the Government servant concerned (prior to 04.10.2006) / on the basis of the date of death of the Government servant concerned, provided the application is preferred within three years from the date of death of the Government servant concerned (with effect from 04.10.2006).
